On behalf of Magen David Adom (MDA) and the countless people who will benefit from your gift, please accept our deepest appreciation. Your generosity is supporting MDA's mission as Israel's emergency response, blood services, and disaster relief organization.

The attack by Hamas on October 7, 2023, was unprovoked, barbaric and unimaginable. With over 1,400 Israelis murdered, and thousands more wounded, MDA has played a heroic role in treating those in need from mere minutes after the first alarms were sounded. Three of MDA's EMTs were murdered by terrorists even as they were treating patients, and an additional seven who were called up for reserve duty as IDF medics, were murdered in the hours and days that followed. Eleven of our ambulances were destroyed and one more was driven into Gaza and torched. Your generous gift enables us to purchase additional medical supplies and equipment.

At the bottom of this letter is the documentation of your generous gift. As a 501(c)3 charitable organization, AFMDA is committed to raising the funds MDA needs for its emergency vehicle fleet, medical equipment and supplies, and to build the critical facilities that serve the people of Israel.
