

**RELEASE, WAIVER OF LIABILITY AND ASSUMPTION OF RISK
“AGREEMENT” FOR ALL VILLAGES SOUTH JEWISH
CHAVURAH MEMBERS AND INVITED GUESTS FOR 2018**

In consideration of being permitted to participate in any Chavurah sponsored event or activity, or as an occupant in a Chavurah sponsored common carrier, whether private or commercial including, but not limited to, vehicle, transport, carrier or vessel, and referred to hereafter as “event / events”, during the calendar year 2018, I, for myself, and for my executors, administrators, personal representatives, assign, heirs and next of kin, do hereby:

1. **RELEASE AND FOREVER DISCHARGE** The Villages South Jewish Chavurah and/or any of its members including those who planned and participated in the events, for all liability for any loss or damage, and all claims on account of injury to my person or property or resulting in my death; I **COVENANT NOT TO SUE AND FURTHER AGREE TO INDEMNIFY** The Villages South Jewish Chavurah and its individual members and/or Officers and/or its Directors against claims of damage to the person or property of any other person alleged to have resulted from my participation in the events whether caused by my negligence, action or inaction or by those I hereby release; and

2. I understand that commercial and personal common carriers, transportation vehicles, transports and/or vessels occur accidents and collisions causing serious personal injury, property damage and death, and may involve negligent rescue operations. Knowing the risks of traveling in these methods above, I agree I freely and voluntarily agree to assume those risks: and for my executors, administrators, personal representatives, assigns, heirs and next of kin hereby release and hold harmless all those who either planned or participated in the event including voluntary rescue operations; and

3. I agree this **RELEASE, WAIVER OF LIABILITY, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT** is intended to be as broad and inclusive as permitted by Florida law and that if any portion of this Agreement is held invalid for any reason, the remaining portions shall continue in full force and effect. I further agree that the intent of this Agreement is to discharge, in advance, those who planned and those who participated in any event and to **IDEMNIFY THEN AND HOLD THEM HARMLESS** for any injury that I may be involved in, while participating in a Villages South Jewish Chavurah sponsored event; and

4. I agree I will not be permitted to participate in any Villages South Jewish Chavurah sponsored event unless I sign this **RELEASE, WAIVER OF LIABILITY, HOLD HARMLESS AND ASSUMPTION OF RISK AGREEMENT**, and I have read the forgoing Agreement in its entirety and I hereby freely and voluntarily sign this Agreement, intending to be bound thereby; and

5. By my signature below, I agree to this Agreement, and to a proper Code of Conduct, established at all times by The Villages South Jewish Chavurah, or by any Villages management authority. I further agree that my participation or involvement in, or presence at, a Villages South Jewish Chavurah sponsored event is a privilege rather than a right. The Villages South Jewish Chavurah reserves the right within its sole discretion to revoke my event privileges and/or my membership; and

In an event or situation when there is a conflict or interpretation between this Agreement and a separate agreement(s), I further understand and agreed that this Agreement shall control:
